The Special Town Meeting was held on Monday January 11, 2016 at the Rowe Elementary School. The meeting was called to order at 7 p.m. by Moderator Robert J. Clancy. There were Thirty (30) registered voters present and One (1) audience member. Moderator Clancy turned to the Board of Selectmen for comment before reading the special town meeting warrant.

Board of Selectmen Chair Marilyn Wilson shared that the certified free cash amount is \$371,773. The monetary amounts on the special town meeting articles are \$34,997 and the \$150,000 to stabilization leaves the total free cash at \$186,776.

ARTICLE 1: A motion was made and seconded to Appropriate from Free Cash the sum of \$2,409.95 to purchase instructional materials for the Rowe Volunteer Fire Department.

ARTICLE 2: A motion was made and seconded to Appropriate from Free Cash the sum of \$10,000.00 to purchase twenty (20) new pagers for the First Responders on the Fire Department.

ARTICLE 3: A motion was made and seconded to Appropriate from Free Cash the sum of \$4,000.00 to remove the trees in the front of Town Hall.

ARTICLE 4: A motion was made and seconded to Appropriate from Free Cash the sum of \$5,520.00 to repair the gate at the Refuse Center.

ARTICLE 5: A motion was made and seconded to Appropriate from Free Cash the sum of \$3,000.00 to purchase an Emergency Support Vehicle for the Rowe Volunteer Fire Department.

ARTICLE 6: A motion was made and seconded to create an Assessors Triennial Evaluations Stabilization Account with the \$15,000.00 which was voted on May 11, 2015 at the Rowe Annual Town Meeting.

ARTICLE 9: A motion was made and seconded to establish the position of Relief Animal Control Officer and to appropriate from Free Cash the sum of \$500.00 to fund this position.

ARTICLE 10: A motion was made and seconded to move \$3,000.00 from the Treasurer Line Item 01-5-145-100 to the Assistant Treasurer Compensation Line Item 01-5-145-110.

ARTICLE 11: A motion was made and seconded Appropriate from Free Cash the sum of \$ 2,478.00 to upgrade and repair the smoke detection system and replace faulty smoke detectors in Town Hall

ARTICLE 12: A motion was made and seconded to Appropriate from Free Cash the sum of \$ 4,000.00 to repair and bring up to code the Town Hall elevator.

ARTICLE 13: A motion was made and seconded to Appropriate from Free Cash the sum of \$607.00 to purchase a suction unit for the Emergency Medical Service.
