The Rowe Board of Health will meet at a duly posted meeting on April 3, 2024 at 6:00 pm.

Based on the record, the Board of Health, pursuant to 105 CMR 410.700, will hold a hearing at the request of the Shantigar Foundation at 6:00 pm on April 3, 2024. The purpose of this hearing is to hear the request of Sanitgar Foundation for a variance to 105 CMR 410.110(A)(2).

At this hearing, as owner, you shall be given an opportunity to be heard, to present witnesses or documentary evidence, to show that the enforcement of 105 CMR 410.110(A)(2) would do manifest injustice.

Final Decision after Hearing:

The board of health shall notify the petitioner and all affected persons in writing of its decision to grant or deny such variance.

Any variance granted by the board of health shall be in writing and shall include:


- (1) The factors determining that the enforcement of this provision in 105 CMR 410.000 would be a manifest injustice;
- (2) The measures the petitioner will incorporate to ensure equal or greater protection of the health and safety of the occupants as provided by 105 CMR 410.000; and
- (3) The date of expiration of the variance.
