Board of Selectmen

The Board of Selectmen respectfully submits this report to the taxpayers and citizens of the Town of Rowe.

As in the past, your Selectmen have been meeting every other Tuesday to conduct the business of the town.

In January the Board held meetings with all the departments of the town that the selectmen are responsible for in preparation for the budget meetings with the Finance Committee.

At a February meeting the Board was very pleased to have Karl Jurentkuff and Bud Pierce come in and volunteer to be on the Old Home Day Committee for 1996. They also recommended Judy Pierce, Pearl Jurentkuff and Dick and Chris Tower, with Terry and Laura Krumm to act as consultants. The Board quickly voted to appoint these very highly qualified individuals. Old Home Day 1996 turned out to be a great success, and the Board would like to extend their thanks to the committee and all that worked so hard to make this another memorable day.

At another meeting in February, J.P. Migeon, our Emergency Medical Services Coordinator, recommended that we appoint Dan Miller as an Emergency Medical Technician for Rowe. The town is very fortunate to now have three highly qualified EMTs: J.P. Migeon, Gail May and Dan Miller. We would like to thank these three individuals for their dedication in attending to the medical emergencies in our town.

Another update on the Town Line Bridge replacement: The contracts for the design of the bridge have been awarded and as of February, this work was sixty percent complete. At this time we do not know when the actual building of the bridge will take place, but we do know that the project is still progressing.

In April, after discussions with other towns and a representative of Yankee Atomic Electric Company, the board voted to support Federal legislation that would require the Federal Government to provide an interim storage facility for high level nuclear waste materials. Letters for the support of this legislation were drafted and sent to Senators Kennedy and Kerry and Rep. John Olver. This legislation was not acted upon.

At a June meeting there was a discussion regarding a citizens offer to donate an antique British telephone booth to the town to house a public phone outside the town hall. It was agreed that the board would oversee the restoration and the installation of it in a suitable location. At the writing of this report, the phone booth has been moved to the town barn where it will be sandblasted and painted.

In compliance with Federal law, the town has instituted a drug and alcohol testing program for all highway department employees. This program is conducted by Foley Laboratories. We are pleased that the program has been operating smoothly since July.

In October, the board regretfully accepted the resignation of Robert Kenney as Deputy Fire Chief. Mr. Kenney was a very faithful member of the Rowe Fire Department for many years. His reason for retiring was because he was moving to Florida. The board thanked him for his many years of service and wished him well.

As always, our dedicated Highway Department continues to maintain our roads in excellent condition throughout all seasons. During the summer 4.35 miles of roads were resurfaced, a new and larger drainage pipe was installed across Davenport Road. New guard rails were installed on Zoar Road hill. Remaining sections will be completed this spring.

In June, Rowe made the news when the route of the ESPN X Games second annual Adventure Race came through town. Racers rafted down the Deerfield, hauled out below Pulpit Rock, climbed up over the rocks, orienteered to Ford Hill Road, and biked through Rowe to Legate Hill in Charlemont.

In May, our Town Clerk, Norma Brown, chose to not run for re-election after serving the citizens of Rowe in that capacity for twenty-three years with great dedication and good humor. The Board thanks Norma for her long service to the Town. She continues in her duties as Tax Collector.

On July 23, a cask in excess of 90 tons was transported through Rowe on its way to the Yankee Atomic Electric Company facility. Many residents turned out to witness the spectacle. The cask will be used to remove the reactor vessel from the Yankee plant.

Four of our neighbors, all of them longtime Rowe residents, passed away in 1996; Mike Cascone, Ray Stevens, Charlie Avery and Dot Bainbridge. We are all saddened by their passing.

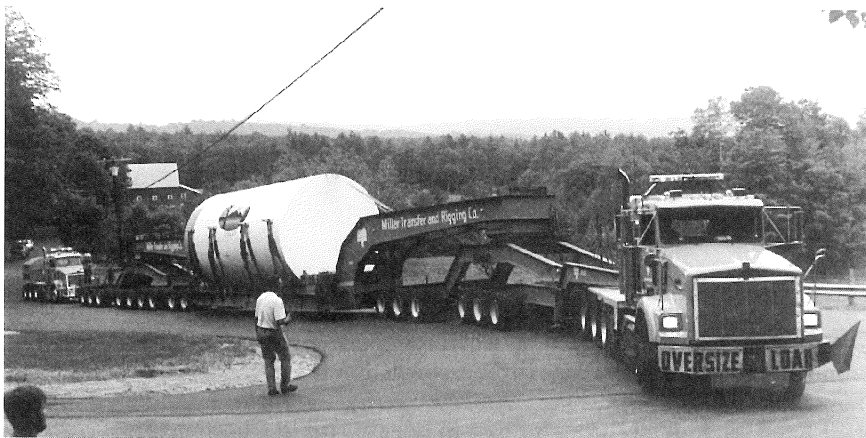
In closing, the Board of Selectmen would like to thank all our town employees, elected officers and committee members who work so hard to keep our town functioning. As always, we appreciate your continued support.

Chairman Bob Kenney chose not to seek re-election and Rick Williams was elected to the position joining Lenny Laffond and Ellen Foberg on the Board. We would like to thank Bob for his many years of dedicated service on the Board and wish him well on his retirement in Florida. The Board of Assessors also accepted with regret the resignation of Assessors Clerk Nancy Hazard. The need to find full-time employment forced her decision to leave. Nancy had been with the Assessors for several years and had done an excellent job. We wish her well in her new endeavors. We were fortunate to quickly find a highly competent replacement right in our backyard. Sandy Daviau, who lives with her husband Ed on Potter Road, was hired to fill the Assessors Clerk position. Sandy was able to attend the State Assessors Course 101 at UMass along with Lenny Laffond in late summer. Sandy has learned very quickly the details of the job and has done very well at keeping things running smoothly through this revaluation year.

A complete review of all property values (revaluation) is required by the state every three years. The results of the 1996 revaluation showed a drop in total town valuation of \$1,548,807 to \$155,417,533. Based on the results of the 1996 Annual Town Meeting, the tax rate for Fiscal Year (FY) 97 was set as follows:

\$5.34/\$1000 - Residential (R)

\$11.70/\$1000 - Commercial/Industrial/Personal Property (CIP)

As we move towards the year 2000, several significant issues are facing the Town and its ability to maintain a stable tax base. The continued dismantlement of the Yankee Atomic Electric (YAEC) facility and the impact of pending Utility Deregulation on the New England Power Company (NEPCO) facilities are two issues which have the potential to significantly affect the Town over the next few years.

The YAEC facility is currently valued at just under \$17 million, down from a high of just under \$60 million when the plant was operating. As Yankee nears the end of its decommissioning process, we expect the company will try to get its valuation further reduced. If on the other hand Yankee decides to build a dry cask spent fuel storage facility, then its valuation will increase. We expect to meet with Yankee representatives early in 1997 to discuss this issue.

The NEPCO facilities are currently valued at just under \$133 million. The utility has informed the town that they intend on selling their generation facilities and focus primarily on transmission and distribution as part of the

deregulation process. The utility would have us believe that their hydro facilities are presently over-valued but other industry experts predict the hydro facilities could bring in bids higher than the present book values. With deregulation due to take effect on January 1, 1998, we will be closely watching the process during 1997.

Another potentially negative aspect of the deregulation process for the Town of Rowe is the so-called manufacturer's exemption. Under Massachusetts law, manufacturing facilities are exempt from paying personal property taxes on all machinery including electric generating machinery. Therefore the potential exists for a company to come in under the new deregulation rules and buy up the NEPCO generation facilities and seek "manufacturing" status in order to avoid paying taxes on their electric generating machinery. As you can imagine this could have a devastating effect on Rowe's tax base. We are currently working with our state legislators to support a Massachusetts Municipal Association-sponsored bill to preserve the ability of towns to tax all property and real estate of electric generating facilities.

For FY 97, the percentage of tax burden borne by the utilities versus the residents was approximately 83% vs 17% clearly anything which affects utility valuation in a negative way will have an adverse effect on residential taxes, if current levels of spending are maintained. The Board of Assessors have retained the professional consulting services of Patriot Properties to assist us in dealing with these impending issues.

Fire Department

During the last report period the Fire Department responded to eighteen calls:

3	Smoke in House
3	Traffic Accidents
3	Fire Detection Activation

As a result of the Department's chimney cleaning program, twenty-three homes' chimneys were inspected and/or cleaned this year. In the coming year, as in the past, we will clean the chimneys of the elderly and assist able-bodied residents. We will attempt to conduct the cleaning in August and September, before the heating season, so names should be submitted early.

The Fire Department is made up completely of volunteers from town. The effectiveness of this organization is determined by the number of individuals it can train and maintain in a state of readiness, and by the condition of its equipment. We welcome anyone who is interested in protecting his-her own and his neighbors' lives and property from the potentially devastating effects of fire. Not all of the activities required to prepare for and combat a fire involve hands-on fire fighting. There is plenty of other work with which we could use help. Our program of regular monthly training/meetings is announced in the Goal Post for each upcoming month. These sessions are approximately one hour in length. This is a small investment of your time when you weigh it against the potential benefit that may be derived from your membership. The officers of the department would like to take this time to thank all members who participate in our activities regularly, and ask other towns to become involved.

Enhanced 9-1-1 became operational in December of 1995. You have to dial only three digits, 9-1-1, to notify the Rowe Fire Department, Police Department and Emergency Medical Services of emergency situations. When you make a 9-1-1 call the dispatcher has the telephone number, the name listed for that number and the address of the originating phone location on a computer screen in front of him/her. When assistance is needed, call 9-1-1 **immediately**, do not waste precious time trying to contact a friend, neighbor, or member of the department for assistance.

At the time of this report we are soliciting proposals for the consolidation of the Fire Department, Highway Department, Police Department and Civil Defense radios into a single control console in the communications room of the fire

station. This will eliminate the need for the individual remote controllers located in different areas of the fire station to monitor and provide communications during any emergency and consolidate them into a single room.

After many years of service Bob Kenney resigned as deputy chief this year. Bob has been deputy chief for the last twelve years, but has been an active member of the fire department for many years. Bob was one of the "Red" phone holders until we activated a full time dispatch center. The Fire Department was only one of many town functions/responsibilities to which Bob dedicated himself. I want to wish Bob well in his retirement and thank him for his many years of service to the Rowe Fire Department.

as a busy year for the Planning Board. The firm of Philip B. Herr & Associates was contracted to assist us in conducting a comprehensive town-study to provide guidance and direction in planning for Rowe's future. (Mr. Herr was the consultant in the first Goals for Rowe study conducted in 1975, providing us with valuable insight and continuity.) We called this study "Goals for Rowe II". The study consisted of two workshops for the townspeople, one in May and the second in October. The summer months were devoted to a survey, similar but not identical, to the survey conducted in 1975. We were most fortunate to find the perfect young man, Steve Whitman, a graduate student in planning at the University of Massachusetts, to conduct the survey interviews. Approximately 65% of the households in Rowe were interviewed. Results were tabulated, reviewed and results were used in conducting the second workshop in October. Finally, our consultant pulled it all together into the final report, mailed to voters in March of 1997.

We hope that the final report, as well as those "intangible" lessons gleaned from the process itself, will be utilized in planning for and implementing a new set of "goals" for our town.

We are also beginning the process of assessing our existing by-laws, with an eye toward either revisions (if needed) or simply reprinting. Many town officers have asked us for a indexed by-law book and that issue will definitely be addressed.

Our meetings are at the town hall on the first Thursday of the month, or as otherwise posted. The public is always encouraged to attend.

School Reports

Rowe School Committee

1996 was a year of many changes for the Rowe Elementary School. It was a year of tough decisions and forming a school with enhanced educational programs and down-sizing enrollment.

In June we saw the Town of Heath withdraw from the Rowe School after twenty-five years to start on an exciting adventure with their own town school.

The summer was spent restructuring the school physically; to meet the new multi-grade classroom concept, to accommodate a three-day per week preschool, and to work with school of choice students. We were able to transform the main lobby into a welcoming, homey atmosphere with the hard work of a committee of townspeople and staff. With the help of Terry Krumm our hallways, library and main lobby were revitalized with all new carpet. Fall saw the replacement of the roofing over our gymnasium.

All through the summer months, staff worked hard developing the new curriculum, sorting through supplies, cleaning and relocating furniture. The school was able to restore many areas to their former functions. The cafeteria was moved out of the gym and back to the area designed for it. The art room was reopened, the library moved out of the main lobby back to the classroom area, and a dedicated computer room was created.

Due to the decline in enrollment with Heath children leaving, the school committee voted to go school of choice and allow non-resident children to enroll. The committee allotted twenty-two seats and felt we would probably fill three to four the first year, and attract additional students as our curriculum developed. We were surprised when not only all the seats were filled, but a waiting list developed. We started our new school year in September with 25 Rowe students, 22 school of choice students and 6 preschool students.

The bill filed with the state legislature to redefine school spending for the Town of Rowe failed. The school committee, finance committee and selectmen continue to work on similar legislation in 1997 to set a new base year expenditure amount for Rowe under the Education Reform Act.

This year has been one of new challenges and excitement for the Rowe school community. We encourage all to attend our meetings or stop in at the school to see all the changes, and the *spirit* that is alive in our children, staff, parents, community members and school committee.

Your kindergarten teacher Roberta Baker gave birth to a boy, Madison, in November, and is due back from maternity leave in April. In her stead we hired Christine Kovalchick to substitute. Another good addition to the staff is Christine Harrington, hired for the resource room.

Special programs for the year range from the all school hike, the winter enrichment ski program at Berkshire East, and an educational performance Galileo, artisans in residence, a trip to the Montshire Museum, the Cape Cod/Natures Classroom, and more. In summary the 1996-97 school year was an active year filled with some new, some ongoing, but all enlightening and exciting activities that provided another dimension to the new curriculum.

The community lunch still happens too. So make that your excuse to come in and see what is happening in your school.

Superintendent of Schools

At the beginning of this, the fourth year of the existence of the Mohawk Trail Regional K-12 District, we can look with pride at the progress we have made in bringing about a closer union of the three districts that joined to make up the K-12 district. Since both Hawlemont Regional and Rowe School District feed children to the Mohawk Trail Regional Jr.-Sr. High School, they have shared in many of the activities undertaken in the Mohawk District.

This year has seen the completion of the new Heath Elementary School. Philip O'Reilly, chosen as the school's first principal, presided over its dedication on August 24th. The occasion brought together well over 300 people from the community and neighboring towns. This Spring also saw the ground breaking for the addition to the Colrain Central School as well as the construction of the new Sanderson Academy in Ashfield. The completion of these two projects this coming summer will mark the completion of three of the five building projects approved by the citizens of the eight towns making up the Mohawk Trail Regional K-12 District. The remaining two projects are scheduled to begin this Spring. These building projects are concrete proof of the dedication of these communities to offering the very best for their children — something we can all be very proud of.

This year also saw the settlement of the new K-12 Teacher Contract. Negotiations were long, but when an attempt is made to combine three contracts into one unified contract, one can expect that the task will not be simple. The new K-12 contract was a fair settlement that will now be used as the foundation for new negotiations that will soon begin. The new contract guarantees equality of treatment and salary for all professional employees of the District.

This past year also saw the rewriting of an integrated K-8 hands-on science curriculum. When interviewed for the position of Superintendent, I was informed that one of my goals would be to orchestrate the revision of all major curricula so that all schools feeding into the Mohawk Middle School would teach to the same grade level standards in each curriculum area.

The mathematics curriculum was revised in 1995 with grade level standards set for each elementary school in the Mohawk Trail Regional School District as well as the Hawlemont Regional and Rowe Elementary Schools. This marked the first time that all teachers at every grade level were to teach to similar standards and exit outcomes. This past year, the curriculum for K-8 hands-on science was produced. This year we are working on Language Arts. Revising and rewriting curricula are laborious tasks and take much time. We cannot

rush through this work if it is to be lasting and truly reflect what we want all children to know. All of the teachers have been involved in this all-important task which will produce the very best programs for the children of our Districts.

This year saw the down-sizing of the Rowe Elementary School with the opening of the Heath Elementary School. Determined to maintain an elementary school that would offer superior programs coupled with new and innovative teaching methods, the staff welcomed 52 students, 26 of whom were School of Choice students. The School Committee and Administration are determined to do what is necessary to guarantee the success of its "new" school.

The Hawlemont Regional School Committee, concerned with the physical needs of the school, had worked with a Building Committee of citizens to bring to the townspeople an addition-renovation project to meet the needs of the children of those two communities well into the Twenty-first century. Defeated at the town meeting, an alternative plan is being developed to present to the citizens this coming year.

My goal for the coming year is to continue supporting activities that will help develop common goals, common curricula, etc. to help guarantee the successful implementation of educational reform in the Mohawk Trail Regional, Hawlemont Regional, and Rowe School Districts.

Mohawk High School Principal

It is my pleasure to present my sixteenth annual report as Principal of Mohawk Trail Regional School. This year is marked by continuing change in educational planning and direction and by high levels of student achievement.

Plans are now in progress to bid the high school construction project. Actual work is scheduled to begin in March of 1997 and will commence with the construction of a 16 classroom middle school addition in the front of the existing school. Locker rooms will also be refurbished during the spring and summer months. The renovation of the existing building will then take place in several stages and completion is anticipated in 1999.

This school year opened with an increase of 40 students, mostly on the high school level. We anticipate another 20 student increase for September, 1997. This will mean that the school will sustain a 120 student growth in the past three years and we will have a total population of 900 students.

A new student schedule was implemented this year. Instead of 7 year long 45 minute periods, students now take three 90 minute and one 75 minute periods each semester. Study halls have been reduced significantly and will be eliminated in the fall of 1997. Since adoption of the new schedule the school's honor roll has risen significantly and student failures have dropped sharply. Two Mohawk students, Luke Avery and Alicia Belair, were named National Merit Scholarship Semifinalists (the only two public school students in Franklin County) and six others received commendations.

This year the school received a second year grant from the Department of Education to join the Coalition of Essential Schools, a nationwide reform movement. Funds will provide staff training and professional development. Four days of training were conducted this summer at the school by The National Faculty of the CES and was directed at allowing the staff to set goals for the school and to develop strategies for teaching in the long block schedule. This year we are networking with the schools in Western MA who also subscribe to the principals of the Coalition.

Our athletic programs continue to build and grow in size. Several teams have gone to state tournaments this fall. Fundraising continues so we can provide for lighting for the athletic fields. The middle school musical "Wizard of Oz" was a great success and sold out the auditorium for three consecutive days. Over 2,000 people viewed the musical and some were turned away at the door. The all-school musical "Crazy for You" is now in production for performance in the spring.

We thank our communities for their continued support of education programs and facilities improvement at Mohawk. We owe a special debt of gratitude to the School Committee, the Mohawk School Council and the Parent-Teacher Organization for their unwavering support of quality education for all students.

Department of Special Education

As of December 1, 1996, there were 376 children receiving special education services throughout the nine towns of the Mohawk Trail Regional School District, Hawlemont Regional School District, and Rowe Elementary School. This accounts for approximately 20% of the total student and pre-school population (down 2% from last year). The majority of special services are provided within the individual's school district whenever possible. When, as in some cases, it becomes more effective to provide out-of-district services, such services are sought.

Chapter 766 of the Acts of 1972 requires that services be provided to a "...school age child; any person of ages three through twenty-one up to his/her twenty second birthday, who has not obtained a high school diploma or its equivalent...and who because of temporary or permanent adjustment difficulties or attributes arising from a developmental delay or intellectual, sensory, neurological, emotional, communication, physical factors, specific learning or health impairment or combination thereof, they would be unable to progress effectively in a developmentally appropriate education program and would require special education."

In order to meet the needs of our students, a wide variety of services are provided. A number of these services and their providers cover the entire nine town district, while others are found in individual districts.

System-wide services are provided and consist of occupational therapy, physical therapy, speech-language therapy, and the services of an Early Childhood Coordinator. A great deal of the therapy provided is on a one-to-one or small group basis. The goals and objectives that the therapist and student work on are addressed in the child's Individualized Education Plan. These goals and objectives are periodically reviewed so the child's program will continuously provide for the best possible program.

The Early Childhood Coordinator is responsible for implementing federally mandated child search activities in the nine town area throughout the year. The Early Childhood Coordinator coordinates and/or participates in: a) special needs screening of pre-schoolers ages 3 to 5 years; b) special needs screening of Kindergartners; and c) team meetings for pre-schoolers and Kindergartners. The Early Childhood Coordinator also acts as a liaison with outside agencies serving young children in and from our district. In addition the Early Childhood Coordinator also acts as a resource person to parents, teachers, and other school staff in regards to resources, programs and services for young special needs children.

There are two primary goals in our special education program, one is to “mainstream”, that is, to integrate the children into the regular education program as much as possible. And, two, we have also embarked on a program of “full-inclusion” where and when ever possible, which maintains the child in the classroom all day, regardless of the disability.

There are eleven special needs rooms throughout the nine town district. Most of the students serviced by these programs are seen for subject areas such as language arts, math study skills, etc., while also developing strategies and techniques which are aimed at helping children to both cope and/or remediate the effects of their disabilities on learning. A new program was instituted this year at the middle school. The program is referred to as the Language Based Program and is designed to assist students who have specific language processing difficulties.

Typically, the special education instructor often coordinates the child’s program with that of the regular education teacher’s program. With the added assistance of the special education aides, the goals and objectives of each child’s Individual Education Plan are implemented and regularly evaluated.

Each of the schools within our district receives services from a school psychologist. The school psychologist contributes a variety of services to our schools. Chief among these services are their assessments of an individual’s ability and the counseling provided to individuals.

All of the support services provided within our nine town district depend upon the strong networking of talented individuals. Parents (through individual and Parent Advisory Council support), school personnel, and outside support agencies, all assist in providing guidance in programs for children in both special and regular education programs. It is this coordinated effort that strengthens special education programs and enables us to meet the special needs of those we serve.

School Library/Media Center Report

Our main server located at the Mohawk Trail Regional School Resource Center continues to provide on-line access to the district's Winnebago database of library material. Inter-library loan of print material has dramatically increased as a direct result of greater accessibility to the collections at Buckland-Shelburne Regional, Hawlemont Elementary, Sanderson Academy, Heath Elementary and Mohawk Trail Regional. The Colrain Central School collection will be on-line by September of 1997 and Rowe will be connected to the database by June of 1997.

The district continues to receive a reduced amount of Block Grant funding for school library/media technology; this year's allocation of \$5,321 is earmarked for Sanderson Academy. A grant of \$3,000 for the Comprehensive School Health Initiative was awarded to the Colrain Central School by the International Paper Company Foundation through Veratec. Book Fairs and generous donations provide additional revenue for collection development at all our schools.

The completion of the new Heath Elementary School and subsequent development of a foundation collection of print and non-print material was a monumental project. Library Manager Wanda Musacchio is to be commended for this major accomplishment. The establishment of this collection was made possible in part by a highly successful capital fund-raising campaign which provided approximately \$65,000 for technology, library books, playground structures and other equipment for local education. The new school libraries in conjunction with the building projects for Colrain Central School and Sanderson Academy are well underway for completion next year.

Inservice workshops and professional development opportunities continue to enhance our knowledge in the ever changing field of library science. District staff for 1996 are Toni Wilcox at Buckland-Shelburne, Eugenie Lynch at Colrain Central School, Beverly Williams and Barbara Pantermehl at Sanderson Academy, Candy Cross at Hawlemont Regional Elementary, Wanda Musacchio at Heath Elementary, Martha Rice at Rowe Elementary School and Marjorie Porrovecchio, Julie DuPree, Pat Hinds and Susan Silvester at Mohawk Trail Regional School. The school district library/media circulation statistics indicate that 4,079 more items circulated this year than last.

The Carl H. Nilman Scholarship Fund

The fund was established under the provisions of the will of Carl H. Nilman for the purpose of providing scholarships. Recipients shall be graduates of Mohawk Trail Regional High School who desire and are deemed worthy of post high school education or training and are in need of financial assistance.

This year the awards committee read 121 applications; 46 were from seniors and 75 from graduates. \$31,050 was awarded using 30% for seniors and 70% for graduates. The committee feels that seniors have ample funds awarded from other sources while the graduates have far fewer resources. Thirty-three scholarships totaling \$9,100 were awarded to seniors (71% of applicants) and 67 scholarships totaling \$21,950 were given to graduates (89% of applicants). The awards subcommittee was: Carolyn Jarmulowicz (Colrain), Marjorie Porrovecchio (Charlemont), Marion Scott (Buckland), Kirby Thwing (Hawley) and Alica Tripp (Heath).

From 1991 to 1996 \$62,675 has been awarded to Mohawk seniors and \$122,675 has been awarded to Mohawk graduates for a total of \$185,350.

Student enrollment has increased again this year. It appears this trend will continue as the Franklin County population of high school age students increases and the area schools eliminate the general tract of studies.

Our work experience and cooperative work programs continue to expand and be an effective vehicle for job placement of our students. As of June 1996, our Senior placement record was as follows:

Other Report

Franklin County Solid Waste Management District

To the residents of FCSWMD member municipalities:

The Solid Waste District moved ahead on a wide variety of projects and activities during 1996.

On the municipal recycling front, District towns recycled a total of 3,595 tons of paper, bottles, cans, aluminum, and plastic containers, saving the towns over \$190,000 in avoiding disposal fees, and producing more than \$65,000 in revenue from the Springfield Materials Recycling Facility (MRF). All of our towns scored either an A or a B on the state's Recycling Report Card. The District also received the 1996 Rural Municipal Recycling Award from MassRecycle, the state recycling organization.

At year's end, we were putting the final touches on a new program to save towns money in hauling their recyclable materials to the Springfield MRF. Using two large trailers obtained through a state grant, District towns will be able to send their recyclables to the Greenfield transfer station to be combined with materials from other towns, thereby reducing overall haul costs. The program could be operational by the Spring of 1997.

The federally-funded Waste-on Wheels (WOW) exhibits circulated to District schools, town offices, and a health care facility as well as the Greenfield Home and Trade Show and the Franklin County Fair. The District supplied fifteen free recycling bins to every school in our towns. District staff helped thirteen

area schools set-up or improve their recycling programs, resulting in five tons of paper recycled in the last four months of the '95-'96 school year. A state grant allowed the District to organize a landfill/transfer station attendant workshop. Topics included recycling specifications, regulations, and personal health and safety. In December, the District hosted a two-day workshop for schools on hazardous materials management. This workshop is one component of a comprehensive program to assist schools with proper management techniques of hazardous materials.

The District negotiated a short-term sludge hauling and disposal contract, and continues negotiating with the Town of Montague regarding a long-term sludge processing facility there. Local opposition to the proposed Northfield solid waste composting facility finally caused the developer to withdraw the project, ending many years of effort by both the District and the developer. Our latest long-term disposal hopes now focus on the town of Orange, which received approval from the state Department of Environmental Protection to explore the reclamation of their landfill. If this project proceeds, District towns could have a local disposal option for the next 15 years, at a controlled and predictable cost. The District will continue to work with Orange and state officials to keep this project on track.

Our annual collection of household hazardous waste (HHW) was attended by 618 households from 21 towns. In addition, a dozen local businesses used the collection as a safe, easy, and inexpensive way to dispose of their toxic waste products.

Our Program Director position is now shared by two exceptional people: Lynn Rose of Deerfield, and Jan Ameen of Putney, Vermont. We are fortunate to have two such dedicated and talented people on our staff. Amy Wales of Shelburne Falls is our Administrative Assistant. The District owes much of its effectiveness to the extraordinary amounts of time spent by our Town Representatives, as well as interns and volunteers. Combined, these local people — your neighbors — contributed in excess of 1,200 hours attending meetings, staffing exhibits, and working on projects. They deserve our heartfelt thanks!
