Call to Order: Chair Sokol called the meeting to order at 6:00 P.M.

Appointment:

<u>6:00 pm - Rowe Conservation Commission - Discussion about Tree Removal Process and Farming Practices:</u>

Chair Sokol asked Conservation Commission to explain the process a landowner must follow when better understand the process when someone is making changes to their land for the sake of helping and guiding others. Chair Sanchez explained that what triggers the Conservation Commission to get involved is if a shovel is to go into the ground the person should contact Conservation Commission as they have authority to protect the wetlands and the applicant needs to submit a Request for Determination Application (RDA)

In regards to the questions raised to the Board in a prior meeting from a person performing work for a Rowe landowner, Chair Sanchez said that there were chickens in the road and, in the role of Animal Control Officer, he investigated a complaint about chickens running in the road and a trailer was placed on the land. He then noticed a significant amount of activity on the property and that wetlands were disturbed. Conservation Commission then issued an enforcement order to stop the work he was doing and contacted the landowner to explain that the and what he was doing was illegal and that what he was doing would cause her problems if he did not follow the proper procedures. The land not been farmed in over 20 years so the agricultural exemption does not apply.

Chair Sokol said the goal of the Board was to work with Conservation Commission to resolve the issue and to better understand how to lead people in the right direction.

It was noted that a landowner is removing a significant number of trees an application must be filed along with a plan by an engineer to the MA Forestry Dept. The Forester forwards a copy to the Conservation Commission for their review and input.

Mark Stinson, Environmental Analyst for the MA Dept. of Environmental Protection (DEP) for the Western region, confirmed that new agriculture was excluded from agricultural exemption, and that it expired after 5 years of

non-agricultural activities. The Wetlands Protection Act has been in effect since 1972 and must be followed. Mr. Stinson noted that the DEP map overlay does show some wetlands in the property discussed and he went to the site and assisted them on the Enforcement Order. The Order included a requirement to remove the logs on the stream that were cut and placed and that Mr. Austin should work with a Wetlands Consultant to be delineate wetlands. If not remedied DEP could step in deal with the enforcement.

Chair Sanchez said that the second Enforcement Order to stop work was sent and did stop work and told Mr. Austin that it needs to stop, otherwise the landowner could be subject to fines.

WRAP Grant:

Selectman Silva spoke with Highway Superintendent about the use of the \$117,598 awarded to Rowe from the Winter Recovery Assistance Program (WRAP). Superintendent asked it be spent on the parking lot at town garage to regrade the parking lot to gravel and new pavement with a 3" binder and 2" of topcoat. It was agreed that was a appropriate task to take on.

Highway Planning:

Selectman Silva discussed the larger project in the process that could be accomplished with the loan monies voted on at town meeting. He said Superintendent was in the process of mapping it out and will speak again to fine tune. He explained why he would overlay rather than grinding up roads. Chapter 90 funds will finish roads right to Vermont border this Summer. Treasurer asked about the length and duration of the loan needed for the road work and 5 years was discussed.

Executive Secretary reviewed the information about Juneteenth or June nineteenth as it was added to federal and state legal holidays. She contacted Town Counsel and information was provided that indicated that offices should be closed on the Holiday. Holidays observed by town employees were reviewed.

MOTION TO ADD HOLIDAY: Chair Sokol made a motion amend the holidays observed by the Town of Rowe, that in accordance with MGL Chapter 136 section 12: The public offices shall be closed on all legal holidays except March seventeenth, May twentieth, and June seventeenth; provided, however, in Suffolk county such offices shall be closed on March seventeenth and June seventeenth or the day following when either of said days occurs on Sunday and amend the Personnel Policy Manual to reflect the change. Selectman Silva seconded the motion.
