New Business:

Finance Committee: Finance Committee Chair, Daniel Pallotta presented the Safety Complex Roof Replacement Bid, only one bid was submitted by Capeway Roofing Systems. Mr. Pallotta briefly discussed the options within the big. Capeway bid prices: Steal Seam (at \$329,000.00, over budget) or Asphalt Shingle (\$151,800.00). 3. Woodlands Partnership Grant - Contract: The Town of Rowe has been awarded a Woodland Partnership Implementation Grant of \$23,485.00 for implanting the climate smart forestry plan for Pelham Lake Park.

Partnership Implementation Grant funds of \$23,485.00. The motion seconded by Vice-Chair Semanie was

4. Woodlands Partnership Grant - Contract: The Towns of Heath and Rowe have been awarded a Woodland Partnership Implementation Grant of \$50,000.00 for the continued work to on the Highland Trail located through both Towns.
