#### Yankee Road:

The federal funding for this project has put it on hold due to a required environmental review study that must be completed before any contracts can be signed. As a result, the Town must adhere to federal funding guidelines when using state funding. Consequently, the reconstruction of Yankee Road will be delayed. The Town Administrator prepared an informative letter addressed to Yankee Atomic for the Board of Selectmen to sign.
