FY2026 Budget Discussion

- New Growth and Receipts to date/ Levy Expectations and direction: Rick Williams, the Chair of the Board of Assessors (BOA), attended the meeting to inform Finance Committee members about new growth identified by Sansoucy. He explained that this new growth has increased the levy limit.
- 2. Selectmen Capital Priorities: The Board of Selectmen (BOS) and the Finance Committee (Fin Com) discussed the capital improvement plan, noting that it has not been adequately maintained over the past several years. Finance Committee Chair Pallotta has requested that the Board of Selectmen prioritize updating the capital improvement plan. During the pre-budget meeting with department heads on December 5, it was recommended that both the BOS and Fin Com ask all departments to consider their capital needs and to present these during their FY26 budget hearings.
- Wage & Salary Chart/COLA: Fin Com Chair Pallotta has requested that the BOS postpone setting the COLA until later in the budget process, and department heads will be instructed to input only the next step wage for each employee.
