New Business:

1. National Grid – 1019W1 Project – Abutter Request

National Grid has proposed a comprehensive infrastructure project aimed at installing two new electrical feeders originating from the Bear Swamp Substation. This upgrade is designed to significantly enhance the electrical reliability and stability for the town by providing additional power capacity and redundancy. The project also includes upgrading and installing utility poles on Tunnel and upgrading utility poles along Hazelton Road. The poles are projected to be approximately 4 feet taller than the existing poles.

An abutting property owner is requesting that the Selectboard consider discussing with National Grid the possibility of relocating the proposed project lines underground along the town road along the Tunnel Road portion, rather than cutting a large number of trees to install the new

utility poles. The Selectboard disagreed with the idea of placing the utility lines underground and wishes to proceed with the project as proposed by National Grid.

2. Police Department - 4Runner Update

The Town Administrator informed the Selectboard that the Police Department's Toyota 4Runner is no longer safe to operate. She asked if the Selectboard would like to put the vehicle out for bid, starting with posting in the Rowe Goal Post. The Selectboard approved moving forward.
