Fiscal Year 2026 Begin Commentary

Article 4. Elected Board and Committee Stipends -

The Board of Selectmen (BOS) and the Finance Committee (FinCom) reviewed the Planning Board's request for \$5,200 to cover stipends for each of the five members on the board. After discussing the request, four of the five FinCom members voted in favor of the request. Please note that Chair Pallotta abstained from voting, as his wife is a member of the Planning Board.

Article 5. Elected Town Officer Stipends -

The Board of Selectmen and Finance Committee reviewed the request for a \$1,000 increase to the Town Clerk's stipend. After a brief discussion regarding this request, neither the Board of Selectmen nor the Finance Committee was in favor of the increase.

***When the Town Clerk position becomes appointed by the BOS (FY27), the hours for the Town Clerk should vary each year to reflect the increased time required during the elections.
