## **BOH Concerns & Updates:**

- Herb will be attending the budget meeting tomorrow, December 5, 2024 at 6 p.m. Jan Ameen emailed the FCSWMD FY26 Proposed Budget with proposed updates. The BOH budget is due December 19, 2024 to the Finance Committee.
- Herb will be attending Franklin County Regional Emergency Planning Committee (REPC) December 10, 2024 @4:00 p.m. via zoom. The Board reviewed the BOH Hawlemont EDS Plan. Herb will be following up with Randy Cardonell, Planner for Massachusetts Emergency System in coordination with FRCOG's Emergency Planning Committee.

Nursing Updates: Rachel said her November Individual Statistics were: 8.5 days worked, 84 patients seen. 72 patients were over 65 years. She made 20 house calls, 39 office visits and 25 phone calls. The Foot Clinics are still going very well and have been booked up through February. The COA has started to pay for an extra clinic every 3 months as well as extending the time by 30-60 minutes each time depending on need/availability of a foot care nurse. It has been suggested for participants to offer a \$20 fee for service to help infringe the cost. The Walking Club has gotten very good reviews from residents. The participants have asked to continue as long as possible during the winter months (road walking). The Board agreed that her annual report was very informative and she will submit it to the Town Administrator.
