GENERAL BUSINESS

TRANSFER STATION

Attendants Logs

David read aloud the logs; no action needed. New Attendant Kevin Sprague began work on 8/20

Washout

David met with Barkus Excavating on 9/20 to discuss the repairs needed for the bank erosion:

For now Barkus will remove the loose hay and replace with staked hay bales and staked eco fabric at the location, this work will suffice until the board receives authorization from the Division of Fisheries and Wildlife (endangered species division) to proceed with the Barkus proposal obtained 8/18 which includes the following work:

Remove the fence in three areas

Provide the necessary Geo fabric and install

Dig in and place key stones at the toe of the large wash, Type III rip rap

Finish the large wash with Type I rip rap

Fill the two smaller washes with Type I rip rap

Any surplus fill will be moved off sit

Backfill with compaction

Place a berm outside of the fence area for water control

Reinstall the fence

Seed and mulch all disturbed areas, (berm)

David and Conservation Commission members Ramon Sanchez, Chair and Myra Carlow had a site visit on 9/23. Both members were satisfied with the hay bales and eco fabric placement.

Relocation

The current location of the transfer station poses significant drainage problems and it may be economically beneficial to relocate. The current site will need to be engineered to see if the drainage issues can be remedied at a reasonable cost. Marcella was instructed to contact Trinity Engineers to set up a site visit. David has spoken to Selectman Chair, Marilyn Wilson regarding these concerns and is researching a suitable site in town should the transfer station need to be relocated.

MAPLE HOUSE

Maggie has tried several times to deliver their permit and collect the \$25.00 fee but has been unable to find anyone home. Marcella will mail the permit.
