The Special Town Meeting was held on Monday, May 13<sup>th</sup>, 2024 at the Rowe Elementary Schol, located at 86 Pond Road.

The meeting was called to order at 6:30 PM by Moderator Clancy. In attendance were approximately forty-eight (48) voters and ten (10) guests. Moderator Clancy read out a brief greeting welcoming voters to the Special Town Meeting. He then informed voters of the rules of the meeting. Tellers were not appointed.

Assessor's Chair Rick Williams spoke to the impact of FY25 taxes.

Moderator Clancy asked for a sense of the meeting to permit certain department heads that not registered voters to speak during the meeting: School Principal, Town Counsel, and Fire Cheif. No objections were noted.

Moderator Clancy turned to the Board of Selectmen for comments.
